

2018 YORKTON'S GOT TALENT SUBMISSION REQUIREMENTS

1ST PRIZE: \$1,000 2ND PRIZE: \$500 3RD PRIZE: \$250

ELIGIBILITY

1. All members of an Act must be a Saskatchewan or Western Manitoba resident

2. Participants in an Act may include: a) a participant who performs alone; or b) multiple participants who perform together. Any participant in an Act that is under the age of 18 as of the date of submission must have his or her parent or legal guardian's permission to participate in the audition.

AUDITION VIDEO SUBMISSION REQUIREMENTS

- 1. The Act may submit **ONLY ONE** audition video.
- 2. Audition videos should be submitted to Yorkton.got.talent@gmail.com no later than JUNE 15, 2018!
- 3. Audition videos should be between 2-3 minutes. The Act should include a short introduction (no more than 30 seconds) stating the name of the Act, age(s) of members, where the Act is from and any other information the Act would like to convey.
- 4. Audition videos can be sent as video files or YouTube links.
- 5. Audition videos must not contain material which is sexually explicit, obscene, violent, discriminatory, offensive, threatening, or harassing.

JUDGING & VOTING

- Audition videos will be judged by a Yorkton Exhibition Association panel. If the Act is selected to progress
 to the grandstand "Yorkton's Got Talent" live show on Thursday, July 5th the Act is required to perform
 live on this date. Those selected to perform as part of this show will be contacted no later than JUNE
 25th. Voting will take place after the live performances and winners will be announced that night.
- 2. The Yorkton Exhibition Association reserves the right to disqualify and/or exclude, in its sole and absolute discretion, any individual from the audition process for any reason or for no reason at all.
