RULES:

1. All cattle **MUST** be in the barns & processed between 12 p.m. & 6 p.m., Wednesday, November 7.
2. All cattle **MUST** be CCIA tagged.
3. **NO CLIPPING OR WASHING of Commercial Cattle Show entries! Cattle may be dry brushed only. No use of blowers, spray or foams. Rules will be enforced and exhibitors not abiding will not be allowed to show or sell, and will be removed from the pens with no reimbursement of entry fees. No hoof trimming.**
4. Copy of pregnancy testing certificate **MUST** be submitted prior to cattle being unloaded. Pregnancy tests must have been done after October 1, 2018.
5. Animals may only be shown in class entered (ie. animals shown in a Pen of 3 may not be shown in a Pen of 5). Maximum number of entries per exhibitor per division shall be: Pens of 3 - 3 entries; Pens of 5 - 4 entries.
6. Once an entry has been made in a specific class and division, the classification of this entry cannot be changed after entry deadline.
7. Cattle must be subject to domestic feed/watering. Tubs not supplied.
8. No tests are required for Brucellosis. Arrangements may be made for animals tendered for export to be held and tested. It is recommended that Bred Heifers be treated with IBR, BVD, and PI two weeks prior to the show.
9. All Commercial Cattle Show entries **MUST** show and sell through the sales ring.
10. Females will be sold by the dollar.
11. Upon arrival and before cattle are unloaded, exhibitors **MUST** report to the Barn Boss, under whose direction livestock will be weighed and penned.
12. All cattle must have a completed manifest sheet which must be presented at weigh-in.
13. All heifers entered in bred classes must be guaranteed safe in calf.
14. All purchasers must have a Livestock Release Permit before cattle will be released. (Available at show office).
15. Sale Commission - 3%.
16. Cattle will be released following the sale.
17. **Purebred papers MAY NOT be displayed.**
18. **All individuals 18 and over entering the HSD grounds will be charged gate admission at \$5 per day.**
