

**RELEASE, INDEMNITY AND ASSUMPTION OF RISK**  
For the Grain Millers Harvest Showdown Heartland Ranch Rodeo  
at Yorkton, Saskatchewan, The Gallagher Centre Facilities

**READ THIS DOCUMENT CAREFULLY. IT AFFECTS YOUR LEGAL RIGHTS**

By signing this document you, your family and representatives give up the right to sue.

In consideration of Yorkton Exhibition Ranch Rodeo Committee allowing me to participate in the "Grain Millers Harvest Showdown Ranch Rodeo" on the Gallagher Centre Grounds, and on behalf of myself, my heirs, executors, successors, administrators, assigns and whomever else may have an interest either at common law or by operation of statute (collectively "the Releasor"), I warrant that:

1. I hereby waive any and all claims I may have now and in the future, release from all liability and agree not to sue, Yorkton Exhibition Ranch Rodeo Committee and its officers, directors, employees, representatives (collectively "the Releasee") for any and all personal injury, death, property damage or loss sustained by me as a result of my participation in the "Grain Millers Harvest Showdown Ranch Rodeo", from any cause whatsoever. For the purposes of this Agreement, the "Grain Millers Harvest Showdown Ranch Rodeo" shall include all activities from the time of my arrival at Gallagher Centre Grounds to my final departure there from. \_\_\_\_\_**INITIALS**
2. I am aware that the "Grain Millers Harvest Showdown Ranch Rodeo" is an inherently dangerous sport and includes, but is not limited to, risks due to unpredictable animal behavior; stationary objects, or people; skidding, overturning, sudden stops, braking or accelerating; arena footing inconsistencies caused by weather, or otherwise; availability of emergency medical care; or the negligent or deliberate acts of others. I accept all the inherent risks and dangers of the "Grain Millers Harvest Showdown Ranch Rodeo" and the possibility of personal injury, death, property damage or loss resulting therefrom. I acknowledge that the enjoyment and excitement of the "Grain Millers Harvest Showdown Ranch Rodeo" is in part derived from the inherent risks associated with this sport. \_\_\_\_\_**INITIALS**
3. I believe that I am physically, emotionally and mentally able to participate in The "Grain Millers Harvest Showdown Ranch Rodeo" and that my equipment is mechanically fit for my use in the "Grain Millers Harvest Showdown Ranch Rodeo". \_\_\_\_\_**INITIALS**

I hereby waive the protection afforded by any statute or law in any jurisdiction whose purpose, substance or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release. \_\_\_\_\_**INITIALS**

I agree to indemnify, defend and save harmless the Releasee from and against any and all claims, causes of action, damages, judgments, costs, expenses or liabilities which are directly or indirectly caused by my negligence while participating in the "Grain Millers Harvest Showdown Ranch Rodeo" at Yorkton, Saskatchewan, Gallagher Centre facilities. \_\_\_\_\_**INITIALS**
6. In entering into this Agreement I am not relying on any oral or written representations or statements made by the Releasee to induce me to enter into and participate in the "Grain Millers Harvest Showdown Ranch Rodeo". I further agree that the terms of this Agreement may only be amended by a duly executed written agreement between the Releasee and myself and that this Agreement shall not be effected or altered by any subsequent oral or written representations made by the Releasee or anyone acting on its behalf. \_\_\_\_\_**INITIALS**
7. I confirm that I am the full age of 18 years. I am aware that I am waiving certain legal rights that I may otherwise have. I understand and agree that this Agreement will be binding upon my heirs, assigns, next of kin, executors, administrators and successors. \_\_\_\_\_**INITIALS**
8. I have carefully read and understand this Agreement prior to signing it and I enter into this Agreement of my own free will and without inducement. I understand that Yorkton Exhibition Ranch Rodeo Committee is relying upon my warranties, release and undertakings when allowing me to participate in the "Yorkton Exhibition Ranch Rodeo". \_\_\_\_\_**INITIALS**
